approved enabling people to build extensions or make alterations to their property. Not all applications go smoothly however, and I would strongly advise people wanting to put in an application to talk to the Parish Council who make comments pertinent to each application. It is worth having pre-application advice from Planning Officers. I am also readily available to discuss any individual plans with anyone in the villages and I frequently act as a go-between between resident and Planning Officer to try to resolve any problems on an informal basis.

### **Issues** raised by the Community

There was a meeting held for the parish councils with the Police and the MP Nick Timothy to discuss the use of motorbikes using the A1101 as a speed track especially at weekends SCC were asked to cut back the vegetation which was obscuring the signs. Since the seasonal closure of the byways to protect them there has been a decrease in the of bikes.

Many of the issues have been highway issues which the Suffolk County Councillor are responsible for. There has been concern raised about the speeding of the traffic and the very large lorries using the roads through the villages and not the directions diversion routes when the A14 has been having refurbishing work carried out overnight.

### **Unitary Councils in Suffolk**

The Government has taken the decision that Suffolk will be served by three unitary councils West Suffolk, East Suffolk, South Suffolk and Ipswich in 2028.

West Suffolk will cover existing West Suffolk Council area and Babergh and Mid Suffolk

East Suffolk will include the current East Suffolk council and parts of Mid Suffolk

South Suffolk **and Ipswich will cover existing Ipswich Borough council parts of Babergh and parts of East Suffolk.**

Elections for the Shadow authorities May 2027 these will prepare for the new councils in April 2028

From 2027 to 2028 the District Councillors and the SCC Councillors will carry out the day-to-day functions of the Councils and the new shadow Councillors will carry out the preparation work for 2028.

There will be town and parish elections in 2027

The election for the Mayor for Suffolk and Norfolk is due to be held on the 4<sup>th</sup> May 2028

### **Better Recycling in Suffolk**

To start in June 2026 there will be additional bins to the blue and black bins

Brown bins are for garden waste and are a voluntary paid scheme at £53

New food waste caddies one small one for indoors and one for the weekly kerbside collection

New green lidded for recycling for paper, cardboard, newspaper, egg boxes

Blue bins for glass bottles, foil trays, tetra pack, plastic bottles, carrier bags, tin foil, compostable food bags

Black bins for nappies and the likes and nonrecyclable items

There are new small recycling centres across Suffolk visit Suffolk recycling centres on line

There will be instructions delivered with the bins on what goes where and collection days.

### **Solar for business**

We have made an agreement with Babergh and Mid Suffolk District Councils to offer companies in their area access to our successful Solar for Business initiative.

This is a pilot between the three councils to help support businesses save money, reduce their impact on the environment and of course provide and-income to support council services.

Babergh and Mid Suffolk District Councils asked if we could extend our initiative into their area to support their businesses and their

environmental ambitions. West Suffolk Council will retain the income from any projects delivered in their areas and, of course, the scheme remains open to West Suffolk businesses.

Businesses can reduce their carbon emissions and save money on energy bills by signing up to have solar panels provided and installed on their premises, for free.

Electricity generated by the panels is then sold to the business at a rate lower than their current tariff and help reduce energy bills.

Solar for Business has been running successfully in West Suffolk for nine years – helping more than a hundred companies to save a total of around £700,000 and 2,000 tonnes in harmful CO<sub>2</sub> emissions per year.

Businesses across Babergh and Mid Suffolk will now also be able to sign up to the scheme.

To be eligible, businesses must be within West Suffolk, Babergh or Mid Suffolk's district boundaries, and must have a minimum electricity consumption of 5,000kWh per year. For a firm paying 25p/kWh this would mean electricity bills of around £1,250 per year.

This pilot is a great example of councils working together and using our local knowledge and expertise to deliver initiatives tailored for our local businesses. It also is part of our strategic priority for sustainable growth and environmental resilience.

### **Housing Pathway Service**

The aim of this service will be to help house and support vulnerable people and to further West Suffolk Council's work in preventing and reducing homelessness.

The West Suffolk Housing Pathway will be tailored to individual needs to help people who need support either in sustaining accommodation or to maintain independent living.

This will include support for people with learning difficulties or mental health needs, people battling drug or alcohol addiction, homeless people and ex-offenders. It will also help people who are working but who need additional support.

The launch of the new service by West Suffolk Council, follows directly on from the aims and actions set out in our [Housing, Homelessness Reduction and Rough Sleeping Strategy](#), which was shaped through public engagement and adopted late last year.

We have secured 39 beds – all previously supported with Housing related Support (HRS). The new service will offer three levels of support from accommodation only through to high level care for people with complex needs who may pose a risk to themselves and others.

Our continued emphasis will be on homelessness prevention while also breaking the pattern of repeat homelessness that sadly happens for some of the people we help.

As agreed last year, the new housing pathway service is backed with £200,000 a year of funding from the council's housing reserves.

The new service follows on from changes by Suffolk County Council to only fund HRS for people to whom it has a statutory responsibility.

While the changes to HRS were initially due to take effect on 1 April 2024, Suffolk Public Sector Leaders provided interim funding for a year to allow time for the district and borough councils to look at alternative provision.

Through this new service we are helping the most vulnerable people in our communities while also working to deliver on some of the key aims set out in our strategy to tackle and reduce homelessness and rough sleeping.

### **Work on the local plan for 2024 – 2040**

The West Suffolk local plan was adopted in Summer 2025. The Government have asked that work on the next plan is started and to be completed in 30 months and the West Suffolk housing delivery per year has been increased from 750 to 1200 per year which will put a large burden on infrastructure. The process for calls for site has already started.
