### **West Suffolk Budget 2025- 2026 update**

Council tax 2025-2026

Band D £203.67 increase of 11p per week £5.85 per year extra

Band A £3.90 per year extra

Band B £4.55 per year extra

Band C £5.20 per year extra

Brown bins increased to £53 from £50.00

Car parking Ram Meadow increased from £2.50 to £3.00 all day

Ram Meadow weekly, season tickets increased by 16.67%

Blue badge £3.00 increased from £2.50 all day

All other short stay Bury St Edmunds cars parks increase of 20p to all tariffs

### **Devolution**

As you know the Government's plans for devolution, which are set out in the English Devolution White Paper [English Devolution White Paper:](#)

[Power and partnership: Foundations for growth - GOV.UK](#) includes the creation of mayoral authorities and the reorganisation of Local Government.

The Government invited areas to apply by 10 January 2025 to be part of its Devolution Priority Programme which would see mayors elected in May 2026. County or unitary councils are the only authorities that can request this. Suffolk County Council made the request as well as asking to postpone their May elections.

Angela Rayner MP, the Deputy Prime Minister and Secretary of State for Housing, Communities and Local Government, confirmed in parliament today (5 February) Suffolk will be part of the Devolution Priority Programme which would see a Mayoral Authority set up covering Suffolk and Norfolk. It is expected that mayoral elections will take place in May 2026.

In addition, it has agreed Suffolk County Council's request to delay its elections in May 2025.

Government has said today it will be writing to all two tier areas nationally regarding Local Government Reorganisation. As yet we have not received this letter but once I have it I will share its contents and make sure you are briefed.

Whatever solution comes forward from Local Government reorganisation it must benefit West Suffolk's communities, the focus must make sure we keep the local in Local Government.
